Consolidate Chickasaw Middle School into Westwood High School and Reconfigure to 6-12 Grade Structure

Recommendation to be effective for the 2026-27 school year

Recommendation

The recommendation is to consolidate Chickasaw Middle School into the Westwood High School facility, creating a 6-12 grade structure.

Rationale for Consolidation

Chickasaw Middle School and Westwood High School are one mile apart and both buildings are half-utilized. The utilization of Chickasaw is 54% and the utilization of Westwood is 41%. There are approximately 400 seats available at Westwood, making it a suitable receiver school for the Chickasaw students in the same neighborhood. Combining the students and resources of the two schools will create more opportunities for all students.

The new utilization at Westwood will be 75%.

The Westwood High School building has new windows, a new roof, and an upgraded HVAC system. The scope of work is under development for facility and grounds investments from a private investor.

Tennessee's school letter grading system provides a snapshot of how each school performed based on student achievement, growth, and college & career readiness. In 23-24, Chickasaw earned an "F" and Westwood earned a "D" letter grade. The School Performance Scorecard (SPS) uses the following performance categories and levels: *Needs Improvement* (1 - 1.99), *Fair* (2 - 2.99), *Good* (3 - 3.99), and *Excellent* (4 - 5). In 24-25, Chickasaw's overall level was 1.9 and Westwood's was 2.5 placing them in the *Needs Improvement* and *Fair* categories respectively.

Students who score "Met" or "Exceeded" on TCAP assessments are considered proficient. In 24-25, Chickasaw and Westwood's math proficiency rates were 4.9% and 5.7% respectively. Westwood's ELA proficiency rate (14.6%) was almost double that of Chickasaw's (7.6%). The Tennessee Value-Added Assessment System (TVAAS) measures student growth from one school year to the next. Level 5 is the highest score possible, and Level 1 is the lowest score possible. Level 3 represents average growth. In 24-25, both schools' students displayed less than average growth with Chickasaw earning a Level 1 and Westwood earning a Level 2 for their Overall Composite score.

Chronic absenteeism is defined as a student who is absent for 10 percent or more of the instructional days for which he or she is enrolled in a school (must be enrolled for at least 50% of the instructional days). In 23-24, Chickasaw's chronic absenteeism rate (46.9%) was six times higher than Westwood's 7.5%. The graduation rate is based on students in the cohort who earned

a regular or alternate academic diploma in four years plus a summer. Westwood's 23-24 state graduation rate was 84.9%.

Chickasaw Middle School had an increase in enrollment from 21-22 to 23-24 but then experienced a decline in 24-25. The average enrollment at Chickasaw across the past five years has been 343 students. Westwood High School has had an increase in enrollment from 23-24 to 25-26. The average enrollment at Westwood across the past five years has been 333 students.

Facilities Profile

Chickasaw Middle School was built in 1971. The building is 133,034 square feet and sits on 15.5 acres. The facility condition index of Chickasaw is 11% and it has \$5,888,942 in ten-year maintenance needs. Westwood High School was built in 1958. It is 181,342 square feet and sits on 20.9 acres. The facility condition index of Westwood is 20% with \$14.3 million in ten-year maintenance needs. However, the recent district investments at Westwood of a new roof, windows, and HVAC equipment accompanied by the facility improvement plans currently in development by a private investor will substantially decrease both the 10-year cost and FCI value below. Chickasaw students will benefit from all the facility improvements at Westwood.


