# Consolidate Georgian Hills Elementary School into Whitney & Hawkins Mills Elementary Schools

Impact Report
October 21, 2025

Recommendation to be effective for the 2026-27 school year

#### Recommendation

The recommendation is to consolidate Georgian Hills Elementary School into Whitney and Hawkins Mill Elementary Schools.

#### **Rationale for Consolidation**

There are five elementary schools within five square miles of each other in the Frayser community on the west side of Range Line Rd. Two of those five schools are small buildings that are nearly full, while the other three schools in the area are underutilized. Currently there are 1,335 K-5 students in these five schools with a combined capacity of 2,175. That is 61% utilization rate between the five schools, or an excess of 840 seats.

The proposal is to close the two smallest schools into the three larger buildings. Georgian Hills Elementary is one of the smaller two schools and is proposed to be consolidated into Hawkins Mill and Whitney Elementary Schools. The facility condition is better at Hawkins Mill and Whitney than at Georgian Hills. Combining the students and resources of these schools will create more opportunities for all students.

The new utilization of Whitney will be 75%. The new utilization of Hawkins Mill will be 72%.

### Consolidated School Academic and Extracurricular Offerings

Tennessee's school letter grading system provides a snapshot of how each school performed based on student achievement, growth, and college & career readiness. All three schools earned a "C" letter grade in 23-24. The School Performance Scorecard (SPS) uses the following performance categories and levels: *Needs Improvement* (1 - 1.99), *Fair* (2 - 2.99), *Good* (3 - 3.99), and *Excellent* (4 - 5). Both Georgian Hills and Whitney scored at the *Fair* level with overall scores of 2.9 and 2.3, respectively. Hawkins Mill had a higher overall level (3.9) than both schools, which placed them in the *Good* category.

Students who score "Met" or "Exceeded" on TCAP assessments are considered proficient. When looking at 24-25 ELA proficiency rates, Georgian Hills' rate (23.5%) was 4-percentage points higher than Whitney's rate or 19.5% and 9.2-points lower than Hawkins Mill's rate of 32.7%. In math, both Georgian Hills and Whitney had proficiency rates slightly lower than 16%, while Hawkins Mill's rate was nearly double that at 29.1%. The Tennessee Value-Added Assessment System (TVAAS) measures student growth from one school year to the next. Level 5 is the highest score possible, and Level 1 is the lowest score possible. Level 3 represents average growth. Of the three schools, Hawkins Mill earned the highest Overall Composite (Level 5), followed by Whitney (Level 4), then Georgian Hills (Level 3).

Chronic absenteeism is defined as a student who is absent for 10% or more of the instructional days for which they're enrolled in a school (50% enrollment required). In 23-24, chronic absenteeism rates were high at Whitney Elementary (69.6%) and Georgian Hills (58.5%). Comparatively, Hawkins Mill had a lower rate of 11.4%.

Georgian Hills Elementary had increasing enrollment from 22-23 to 24-25. However, the school's enrollment has dropped by more than 30 students in 25-26. Whitney Elementary's enrollment has increased in recent years. The school's average enrollment for the past four years is 266. Hawkins Mill Elementary had primarily increasing enrollment from 21-22 to 24-25 but has had a decline in 25-26. The average enrollment over the past five years is 269.

#### **Facilities Profile**

Georgian Hills Elementary is smaller and older than both Hawkins Mill and Whitney Elementary Schools. Georgian Hills is 74 years old; Hawkins Mill is 60 and Whitney is 63. All three buildings have good facility condition index scores in year five, but by year 10, the score of Georgian Hills becomes the greatest. Both Hawkins Mill and Whitney are underutilized, at 48% ad 52% respectively, making them suitable receiving schools.


